

ORDINANCE NO. 467

**AN ORDINANCE OF THE TOWN OF BELLEAIR, FLORIDA,
AMENDING ORDINANCE NO. 455 OF THE TOWN OF
BELLEAIR PERTAINING TO GARBAGE AND TRASH;
AMENDING RATES FOR SINGLE FAMILY, MULTI-
FAMILY RESIDENTIAL AND COMMERCIAL
CATEGORIES; PROVIDING FOR SEVERABILITY;
PROVIDING FOR AN EFFECTIVE DATE**

BE IT ORDAINED BY THE TOWN COMMISSION OF BELLEAIR, FLORIDA;

SECTION 1. Section 10-7 (a) (1) of the Code of Ordinances of the Town of Belleair, Florida, is hereby amended substantially to read as follows:

(1) Residential – Garbage cans and trash containers collected on regularly scheduled days two (2) garbage pickups plus two (2) trash pickups weekly;

*Multi-family shall be defined as any multi-family structure where one or more commercial containers are utilized by all occupants of the building or buildings.

SECTION 2. Section 10-7 (a)(2) of the Code of Ordinances of the Town of Belleair, Florida, is hereby amended to read as follows:

(2) Monthly rates for commercial and professional users:

SECTION 3. Section 10-7 (d) of the Code of Ordinances of the Town of Belleair, Florida is hereby amended to read as follows:

(d) Special pickup. Trash (excluding palm fronds) which does not conform to the above specifications, and all building materials, shall require a special pickup. Such pickups will be billed at a rate of \$51.29 per hour with a minimum charge of \$17.19 per pickup.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court or competent jurisdiction, such provision and such holding shall not affect the validity of the remaining portion hereof.

SECTION 5. This ordinance shall be in effect thirty days after approval and passage on second and final reading, in a manner prescribed by Section 2.11 of the Town Charter of the Town of Belleair.
